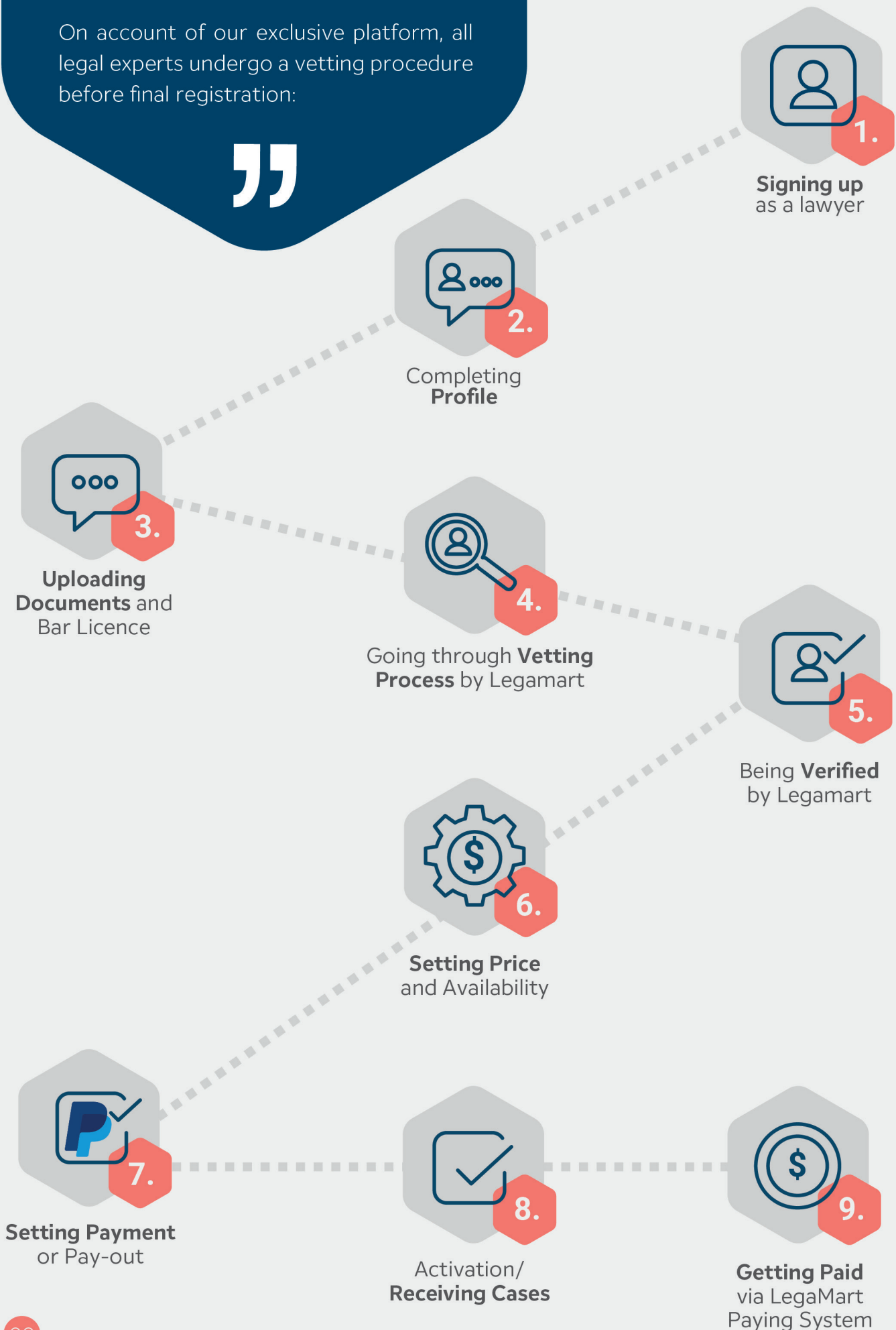

Once appointed, our providers are rated and reviewed by verified LegaMart applicants after each service is completed to ensure that our standards and policies are regulated and maintained.

All lawyers who provide legal service must go through a vetting process and they are required to provide the necessary documents, certification, and proof of membership in the applicable professional associations like Solicitors' Regulation Authority.

## FAQ



### Can I try LegaMart for free?

Membership is free for both lawyers and clients. You will pay LegaMart a service fee of %18.5 only when a transaction is complete, and you get paid by a client. So it simply means no gain, no pay! Moreover, **there are no fees associated with making offers to applicants.**

### Am I working for myself or for LegaMart?

LegaMart is not a law firm but a professional online community platform that facilitates legal services globally.

**Lawyers decide to accept or reject a case.** Agreements are made between lawyers and clients directly.

LegaMart only monitors the process.

### Who can join LegaMart?

**Lawyers providing services can join** LegaMart after their application has been approved by LegaMart and gone through the vetting process. This is a closed network and **only selected and certified professionals** can join and provide legal service.

**Paralegals may also join** but may not provide legal services. While they may be active in the community, writing articles or answering some questions with their own signature.

### Is LegaMart a law firm?

**LegaMart is not and will not be a law firm.** It is merely an online platform designed solely for direct interaction between lawyers and clients in foreign jurisdictions. It helps lawyers manage their marketing affairs.

### What are my obligations as a lawyer?

#### Is it my responsibility to respond to every inquiry?

**No, it isn't. You work on LegaMart at your convenience,** and you decide to participate in any activity. Responding to the inquiries is your personal choice.

### What are the steps for a lawyer to take a case?

When a client submits a legal request, the platform will show those lawyers who have the required qualifications to work on the case (based on the jurisdiction, practice area, experience and language). The client has the option to either choose one or more than one lawyer, contact them and find the most suitable option for the case. Afterwards, both the client and the contacted lawyer(s) have a reasonable time to decide whether to continue on the case with each other or not.



## How does payment work at LegaMart?

All payments run via our online platform. An applicant's payments are sent to LegaMart; we deduct the stated fees and transfer them to your account. So, LegaMart will invoice the client and pay to you under our terms. A legal service provider is only obliged to work on a case upon the applicant's payment.



## I am a lawyer in XXX Bar Association. My education is in YYY Law (every field in YYY Law). However, I live in ZZZ. So which country should I apply for?

You would be considered as an XXX lawyer on our platform. Because in completing your lawyer profile, we ask for your bar licence. Therefore, the jurisdiction where you are qualified as a lawyer is the criterion that we take into consideration.



## Can lawyers handle cases with remote working? (as online)

Since the lawyer might be in one jurisdiction and the client in another, **all the cases on LegaMart will be handled online.**



## What does LegaMart do about banned legal services advertisement according to domestic laws?

We are aware of the limitations some domestic laws place on lawyers advertising their services in countries such as Canada, Germany, Turkey, Nigeria, South Korea, etc. However, considering that LegaMart is not an advertising agency and we do not offer advertisement service to any of the vetted lawyers but rather a platform enabling digital presence.

Advertisement has a common concept of requiring payment to promote a service or product whereas LegaMart is a professional network of lawyers offering some specific services to its lawyers with some wings to the client side of the market, including introducing clients and lawyers together at no fee.

LegaMart (like Legal500 or Lex100) is showcasing professionals such as lawyers digitally and provide them with the infrastructures to enable their digital presence which is not equal to advertising!

If LegaMart was to clash with domestic law, then the likes of Legal 500, Lex 100 and LinkedIn would be facing the same issues; which it is not. It is crucial to understand the difference between an advertisement service and simply having a digital footprint or being a member of the professional network that connects lawyers and clients.



## Can self-employed lawyers provide freelance legal services?

**We completely empathise with your concerns in some specific countries like South Korea. LegaMart assures you there are no limitations on self-employed lawyers to deliver freelance style legal services. Please be aware that lawyers can advise clients regarding various matters with the autonomy to choose. For further information please refer here. The ability to provide freelance legal services, in turn, would allow you to join LegaMart and have the freedom to choose legal issues and also to get more clients..**



## Can clients communicate enough with lawyers before choosing one?
