Introduction

Introduction



The StackExchange platform has proved itself as a vibrant and active community of experts in various fields who are eager to provide expert opinions, help, and guidance to any member who asks for it. Law Stack Exchange, the law related sub-forum of the community platform, which hosts legal experts of many different backgrounds, is no exception to this trend either.

With about 32,000 active users, Law Stack Exchange can be an invaluable asset in market and marketing research based on data analysis, and can provide insight into the trends and prominent issues in the field of law.

The knowledge-sharing platform works by utilizing text-based Questions (also known as posts) and answers. Users in need of guidance can post questions on the forum to be analyzed and answered by experts in the field. Respondents are ranked based on their 'reputation'; a measure of how many helpful answers they have provided. This metric is decided on by the community through a system of voting. Both posts and answers can be edited, responded to, and as such, discussed by many experts, which makes the answers a highly collaborative effort based on goodwill and civil discourse.

Our report is designed to identify trends and provide new insights into the most prevalent issues in the field of law. In order to achieve this, we conducted a mixed-method meta-analysis of data obtained from the Law Stack Exchange platform's more than 18,000 questions, and 380,000 answers, using datasets from the Stack Exchange data dump, accessible at archive.org, licensed under creative commons. This study covers six years of data, from 2015 to March 2020.



Over the past six years, 17972 unique questions have been asked. Since 2015 to March 2020, 26420 unique users have joined the law space, representing a growth rate of 106%. Among these questions, "Copyright", "Criminal Law", and "Immigration Law", have been the most popular tags used to sort questions posed in the community.

Data Assortment And Analysis



Analysis of Law Stack Exchange offers access to a wide variety of information regarding legal issues and practices due to its ubiquitous nature.

The number of unique questions on Law Stack Exchange since 2015 has grown to over 18,000, spanning 26 legal topics. Three topics (Energy and Infrastructure Law, Insolvency Law, and Sports Law) had no relevant questions based on our topic modelling analysis.

Topic Modeling


Our approach to question classification and data analysis was based on the Topic Modeling method. Normally, in this method, set topics (also known as labels) are chosen by analysts based on previously determined criteria. Each topic is assigned a number of marker words, for which the datasets (here the question texts) are crawled for. After tallying and analysis a preliminary topic is assigned to each question based on the occurrence of topic marker words in its text.

At the onset of our study, topic marker words were chosen to be the tags by which the platform's users use to sort their questions. After further analysis, this approach proved not to be as beneficial to our study as expected. As such, we chose to utilize an alternate method of parsing and tagging of data instead of the traditional noun and verb word tagging. This method allowed us to evaluate the types of questions seen on Law Stack Exchange posts, which corresponded to the different legal issues raised on the platform, and the tags utilized by its user base.

We chose to assign specific legal terms and trigger words as topic markers. These terms were chosen based on the insight and expertise of our legal experts to reflect the initial findings of our study. In addition to providing insight into the more common questions among various topics, this study revealed some of the legal practice areas most commonly referred to and needed on the platform.

Initial Topic Sets


Within a total of 23 topics, "Immigration law" is the topic with the highest question volume at 13.16%, followed by "Public Law" at 13.15%, and "Commercial Law" at 10.66%. We see the exact same pattern when looking at how many times users view and/or read questions, with "**Immigration Law**" receiving 13345670 views, "**Public Law**" receiving 13250407 views, and "**Commercial Law**" receiving 10350450 views.



Data Assortment And Analysis



We also see that the trend of topics has remained the same over the last six years (2015 - 2020). For each year, the top tags are "Copyright", "Criminal Law", and "Contract Law".



According to our analysis, the topic popularity trend has remained more or less flat over the years, with "Immigration Law" taking the top spot, "Public Law" coming in second, and "Commercial Law" coming in third.


Trend Analysis: Answered Questions



Out of 17,972 unique asked questions, 16,144 (about 90%) have at least one answer, with 1,828 being left without one. Around 7,343 - or nearly half - of the questions answered by the community have at least one accepted answer (meaning that the community and/or the question's original poster has found the answer to be sufficient), while 8,801 do not.

Questions with one answer are the most frequent, with questions with more responses quickly falling off in numbers within the datasets.

Over the last six years, the year 2018 had the most answered questions (about 93.63%), and the year 2020 had the fewest answered questions (about 82.24%). The year 2015 has the highest accepted answer rate among the following six years, even though more questions were answered in 2018.



Trend Analysis: Answered Questions



Over the six-year period, questions regarding "Immigration Law", "Public Law", and "Commercial Law" have continued to dominate the trend of legal topics, and have received the most accepted answers.




Exchange can be a valuable resource on determining the most prevalent legal trends and the availability of legal expertise in the corresponding fields.

Data acquired from analysis of time data on the platform can be aggregated and presented as follows:

More than 75% of questions on expert topics are answered in a median timeframe of 12 hours. Approximately half of the questions are answered within the first four hours.

Since a question may have multiple answers, the mean differences between posting a question and getting all answers are calculated. After removing the outliers, the data is plotted with the time dimension measured in hours.



Trend Analysis: Answer Times



The following is the duration of time it takes for an answer to be received after a question has been posted. The chart shows that, generally, 2020 had the shortest response time (an average of 3.5 hours) in comparison to the other five years, and 2015 had the longest (an average of 7 hours).





Popular Legal Topics

Popular Legal Topics



A total of 17972 questions have been viewed at least 6 and at most 206225 times. As shown in the plot below, we see the distribution of views over equally sized bins decreases over time, and at an increasing rate each year. After eliminating the outliers, the question views range is between 70 to 355 per question.

From our analysis of the dataset, it is clear that "Immigration Law" related questions get the most views at 13345670 times, followed by "Public Law" related questions with 13250407 views, and "Commercial Law" related questions with 10350450 views.




Question Volume By Country

The United States has been the origin of most questions posed on the platform. Despite this, it must be kept in mind that the fact that Stack Exchange as a platform is based in the US can influence the prevalence and popularity of the platform in the country, and skew geographic data gathered in US' favor.





Over the six-year period, questions regarding "Immigration Law", "Public Law", and "Commercial Law" have continued to dominate the trend of legal topics, and have received the most accepted answers.



Trend Analysis: Answer Times



Based on data trends from tag analysis of posts originating from the five top ranking countries on Law Stack Exchange, the most popular general tags utilized by users are: united-states, united-kingdom, criminal-law, copyright, and contract-law. However, based on our legal term-based data analysis model, the five top tags per country are respectively criminal-law, copyright, contract-law, employment-law, and constitutional-law.

The five most prevalent topics on the platform in the top five geographic locations were aggregated based on our legal term analysis model, and are as follows:



• The Top Five Countries Share Common Tags Of "Criminal Law", "Copyright", And "Contract Law".



Tags And Topics



According to the analysis of topic trends for the six years (2015 - 2020) for all countries listed in the dataset, we can determine that "Criminal Law" takes up 7.18% of questions, "Contract Law" 4.08%, and "Employment Law" 2.24%. With a slight difference, the trend for legal tags for all countries listed in the dataset are "Criminal Law", "Copyright" and "Contract Law" with frequencies of respectively 1312, 1108 and 746, which is in accordance with the topics trend.

- As Can Be Seen From Our Analysis Of The Top 5 Countries, "Copyright" Was Present In 4 Of The Top 10 Tags In Each Of The Countries In 2015.
- As Of 2016, "Copyright" And "Criminal Law" Were Both Among The Top 10 Tags In 4 Out Of 5 Countries.
- All Five Countries In 2017 And 2018 Had The "Criminal Law" Among Their Top Ten Tags.
- In 2019, "Contract Law" Was The Common Tag.
- All 5 Of The Top Countries Had "Copyright" And "Contract Law" In Their Top Ten Tags For 2020.

The United States, the United Kingdom, Canada, Australia, and Germany were the top five countries regarding intrajurisdictional questions.


Among the top countries included in this dataset are the United States and the United Kingdom, with 40 questions (25 from US on the UK, 15 from UK on the US) were asked.



Studying the top ten words of each year shows that "**Copyright**" and "**Crime**" each with a frequency of **6(10%)**, respectively, topped the trend over the years. Terms like "Term", "Lawyer", "License", and "Rule" occur equally, but since they are general terms, they don't provide much analytical value. By examining the frequency of these terms, it is clear that "**Copyright**" with a total frequency of **12648** still has the lead.

"GDPR" is the second most widely used legal term, with a frequency of 1214.

Marker Word Frequency Variation Over Time





Conclusions

Conclusions



The 106% growth in Law Stack Exchange's community from 2015 to 2020 is phenomenal. As of 2020, the community has had 26,000 unique users on its platform, which is yet another testament of its astonishing performance. Due to this growth, the platform has become a hotspot for community discourse between lawyers, legal experts, and prospective clients, which marks Law Stack Exchange as a golden opportunity for data analysis and market research.

By reviewing the community's trends, we observe that the majority of questions asked were regarding "Immigration Law", "Public Law", and "Commercial Law" topics.

As we explore this trend via analysis of tags, we can observe that the most popular tags have been "Copyright", "Criminal Law", and "Contract Law" for the duration which falls under this study's purview, each of which fall into "Intellectual Property Law", "Criminal Law", and "Contract Law" fields respectively.

"Copyright" is the most commonly used term in the community.

Aggregated geographic user data shows that users and community members from the United States, United Kingdom, Canada, Australia, and Germany asked around 76% of questions on the community, and that the most intra-jurisdictional questions posed on the platform have been between the US and the UK.

"Crime" and "Criminal Law" have been the terms with the most occurrences as both topic and tag in these two countries.

Additionally, our analysis of the datasets has shown that the most popular practice area for the online law community has been "Intellectual Property".

Conclusions



The increasing digitalization of the legal field, legal practices and practitioners around the world are accelerating their online presences and marketing efforts. This trend, driven- in part- by the implications of the global Covid-19 pandemic for mostly offline business models, makes apparent the need for a more digital and data-driven business model in the legal industry.

Studies on the state of the legal industry and its market- such as the study at hand- can provide invaluable insight and data, which can be utilized in the process of transition and adaptation to the ever increasing digital and online nature of the market, and for digital marketing, business development, and business intelligence efforts in this field.

As a platform aiming to facilitate this transition in the field of law and create fresh opportunities for legal practitioners who wish to take advantage of this trend, we have chosen to make this study accessible to the public, so that you may utilize in your business' online and digital efforts.
