Stream 1. The proposal requests go straight to your dashboard.



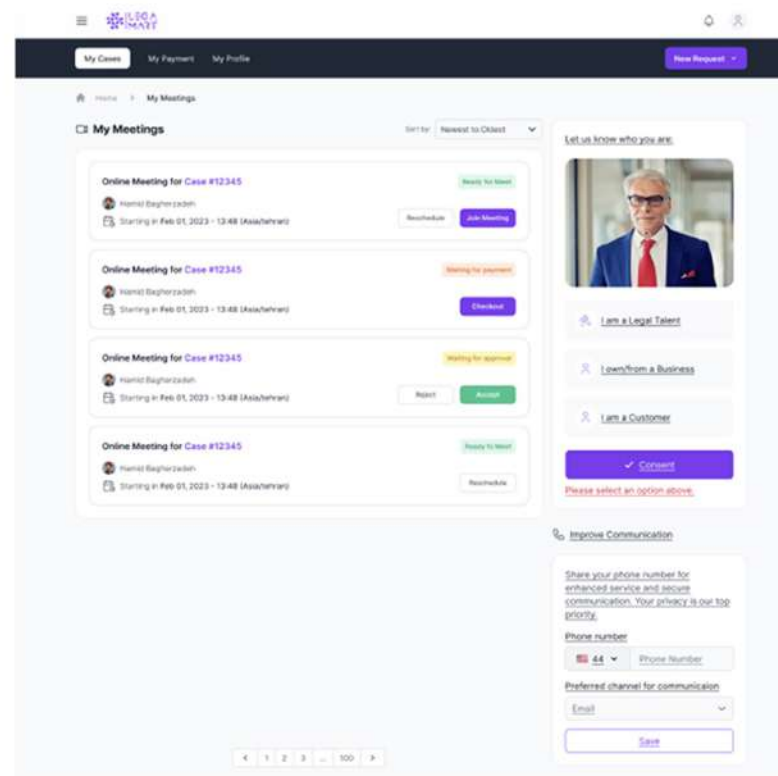

If a client is interested in your services, you will be notified by email and can log in to your Legamart account to schedule an introductory call or to message the client about the prospective engagement. Each new client inquiry will appear as a card on your account dashboard.

Stream 2. Meet with a Client

Clients choose the practice area of the lawyer they are searching for, the lawyer's country, and their preferred language and request a paid quick meeting. If our smart algorithm matches you with their request, they may choose you and you will get infrared on your dashboard and by email.

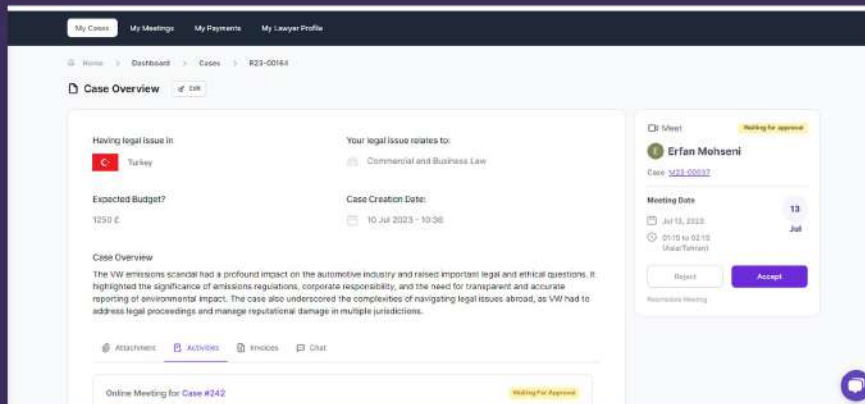

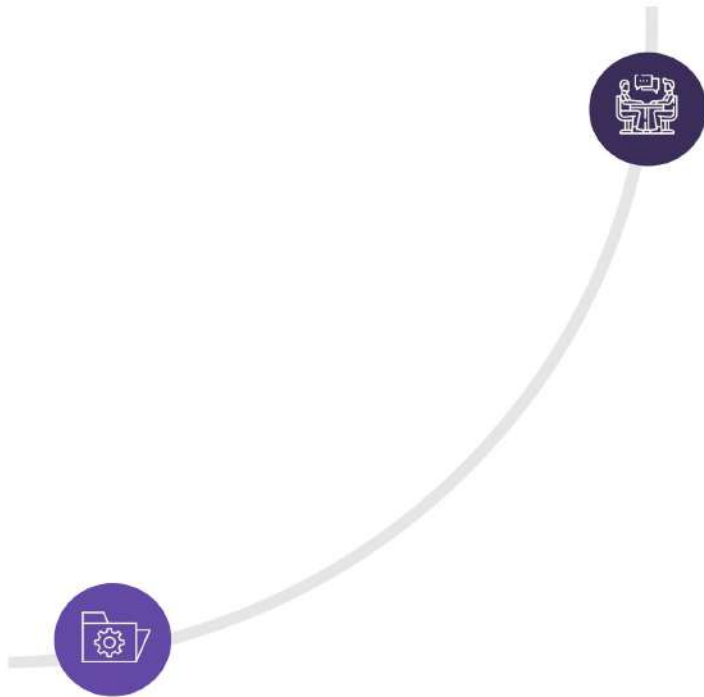
- ★ You will be reminded less than 24 and 48 hours before the meeting started.
- ★ Make sure you have the exact time and date in your mind. Check your mic and video before the meeting.

● During Meetings

- ★ Make sure You understand clients' questions and requests

- ★ Write a summary of what went on during the meeting.
- ★ Your payment will be delivered to your account afterward.



Consultations

If a client is interested in engaging you for a project, you will be notified by email and can log in to your LegaMart account to view the project information and schedule an introductory call (audio or video) to discuss the project in more detail and determine whether it is suitable for you and the client. You can also message the client about the prospective engagement. Each new client inquiry will appear as a card on your account dashboard. Once you confirm a call time, our platform will send you a calendar invite by email with details for the call. The details will also be available on your LegaMart account dashboard.

Declining projects

If you determine that a project is not the right fit for your practice, you are welcome to decline the project via the link on the project request page. Please do not spend time on projects that are not suitable for your practice.

Open project

Once you have sent the proposal, the client will be notified and can view the proposal on their LegaMart account. If the client accepts the proposal, you will be notified by email and provided with the client's contact information to connect and start work. From there, you and the client can work together directly to complete the project, and you will use your LegaMart account to send invoices during the engagement. Each new open project will also appear as a card on your account dashboard.



Engagement

If you connect with a prospective client on our platform and they would like to move forward with the engagement, the next step is for you to send the client a formal proposal for them to consider and accept or decline. You can build and send a formal proposal by viewing the relevant client request on your account dashboard, selecting the "Build Proposal" option and filling out the information on each tab of the proposal builder.



Preparing a formal proposal

Tips For Sending an Effective Formal Proposal

- **Project Description:**

always update the project description on the first tab of the proposal to reflect your arrangements with the client. Volume projects should reference the project's guaranteed engagement hours.

- **Engagement Letter:**

our platform allows you to attach an engagement letter to your proposal so that your client can sign directly on our platform or receive the engagement letter by email or message, depending on preference.

Our available engagement letters vary to suit the different requirements of different attorneys.

However, these letters feature sample languages that we've seen attorneys use, including:

- Billing and invoicing
- service rates
- and management fee

The minimum amount payable by a client as legal fee shall be \$XXX/week (assuming a standard week = to 40 hours of work). Any additional hour will be billed differently. The platform also reduces hours of absence due to illnesses, office closure, vacation, or other leaves taken by the attorney during this time.

- **Rate:**

the rate section on tab two allows you to add your rate. Simply select "Add New Rate" to enter your hourly rate. The platform then calculates the total payable by the client.

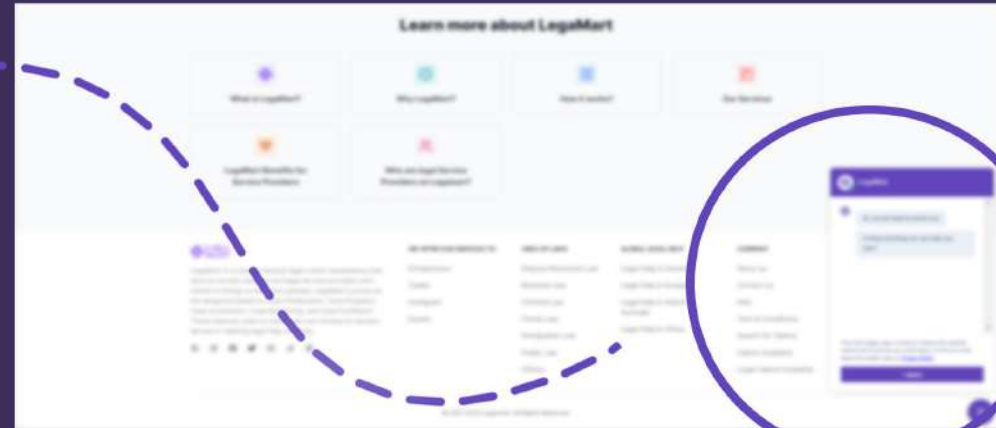
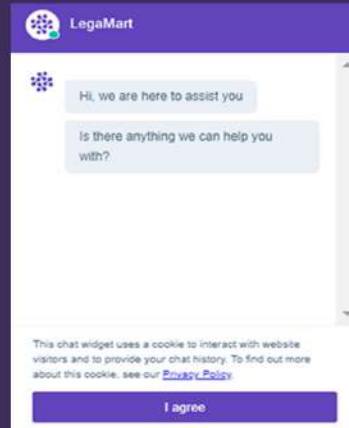
